- [1 Spenard Rd Reconstruction Phase II - Hillcrest Dr to Benson Blvd \(03-22b\)](#)

Status: Apr 13 2015 - Contract amendment for design has been finalized. NTP has been issued to Lounsbury. Development of revised DSR in progress. New funding plan is to pursue federal funds through AMATS.

- [2 Spenard Rd Surface Rehab - Benson Blvd to 36th Ave](#)

Status: Apr 13 2015 - This project has not started. Project funding is proposed with a combination of state grants and local road bonds.

- [3 Spenard Rd Surface Rehab - International Airport Rd to Wisconsin St](#)

Status: Apr 13 2015 - This project has not started. Project funding is proposed with a combination of state grants and local road bonds.

- [4 Benson Blvd at Spenard Rd Area Pedestrian Safety Improvements](#)

Status: Apr 13 2015 - These improvements will be included in the Spenard Rd Reconstruction Phase II project.

- [5 Fish Creek Trail - Northwood Dr to Spenard Rd \(03-27\)](#)

Status: Apr 13 2015 - Project is on funding hold. Project has been designed but is waiting on a state grant for construction funding.

6 [Fish Creek Trail Upgrade - Barbara St Park to Spenard Rd](#)

Status: Apr 13 2015 - This project has not started. Funding is proposed as a partnership of state grants and local road bonds.

7 [Fish Creek Improvements - Cook Inlet to Lake Otis Pkwy](#)

Status: Apr 13 2015 - State grant funding is proposed. Several phases have already been funded and constructed.

8 [Arctic Blvd Surface Rehabilitation Phase III - 36th Ave to Tudor Rd \(02-10c\)](#)

Status: Apr 13 2015 - DOWL is the design engineer. The roadway corridor will be reconfigured to a three lane section. Utility relocation is scheduled to begin in early 2015. Several mobile homes in the Idle Wheels Trailer Park will be removed in late 2014 to allow utility relocation efforts. Utility relocation will commence in spring 2015. Actual road construction is scheduled for mid 2015, depending on the availability of funding.

9 [Lois Dr Upgrade - Northern Lights Blvd to 36th Ave](#)

Status: Apr 13 2015 - State grant funding is proposed.

10 [36th Ave Upgrade - Lois Dr to Minnesota Dr](#)

Status: Apr 13 2015 - No work is underway or scheduled in the six-year Capital Improvement Program. The project will remain on the Capital Project Needs List for future funding consideration.
